## Hatch Chile Recipe Contest

### OFFICIAL RULES

1. NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN THIS CONTEST. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED OR RESTRICTED BY LAW.

2. HOW TO ENTER: Contest begins on 8/16/17 and ends on 9/24/17 (“Contest Period”). Enter by submitting on the Food City website contest page at <http://www.myfoodcity.com/hatchchilecontest>. All entries must be received by 11:59 p.m. on 9/24/17. Submission must include one unique recipe made from hatch chile, including list of ingredients and a photo of the recipe. Limit one entry per person and per household. Neither Bashas’, Inc. (“Bashas’”), nor their respective employees, representatives or agencies, is responsible for lost, late, damaged, delayed, destroyed, misdirected, incomplete, or illegible entries. Once submitted, entries, including images and recipes will become the exclusive property of Bashas’, Inc. Winner will be notified via social media on 9/29/17. Odds of winning depend on the number of contest votes per entry. Entrants and prize-winners agree to be bound by these
