

OFFICIAL SURVEY RULES & REGULATIONS

3rd Annual Tamale Making “Tamalada” Contest for Food City Stores.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. Prizes:

1. There will be 3 winners; First, Second and Third prize winners.
 - a. First prize winner will receive a Food City gift card in the amount of \$500 and a Target gift card in the amount of \$350 (total \$850)
 - b. Second prize winner will receive a Food City gift card in the amount of \$300 and a Target gift card in the amount of \$150 (total \$450)
 - c. Third prize winner will receive a Food City gift card in the amount of \$150 and a Target gift card in the amount of \$50 (total \$200)
2. Prizes will be mailed certified letter to the winner’s home, with a signature required for proof of identity.
3. There is no substitution, transfer, or cash equivalent for prizes, except that Bashas’ may, at its’ sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses.

2. How to Enter:

1. Sweepstakes will begin on November 14 at 12:00 a.m. Mountain Standard Time (“MST”) and end on December 16, 2022 at 11:59 p.m.
2. Entries can be submitted through myfoodccity.com/tamalada. A QR code will also be activated and featured in all in-store artwork.
3. To be eligible, entries must be received within the sweepstakes timeframe and will be based in MST and timestamp of the submission email.
4. To enter online, you must enter your name, valid email address, phone number and photos of the tamale making. Limit one internet entry per household and one internet entry per email address per contest period. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning email address or the domain associated with the submitted email address. Bashas’/Food City (“Sponsor”) is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches. For entry into the sweepstakes without completing the online entry, mail a 3” x 5” card containing all entrance submission information in an envelope no larger than 4 1/8” x 9 1/2” to: Food City Tamalada Contest, PO Box 488, Chandler, AZ 85248. Mail-in entries must be postmarked no later than December 16.

1. The sweepstakes is open to participants who are 18 years of age or older and legally reside in Arizona or New Mexico. 1. Following completion of the entry period, all submissions will be reviewed by the Bashas' Public Relations Department. Each entry will be reviewed on a 1-10 scale based on creativity, photos and description. Finalists will be identified and announced on December 20, 2022.
