

OFFICIAL SURVEY RULES & REGULATIONS

Hatch Chile Recipe Contest at all Food City Stores.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. Prizes:

1. There will be one (1) grand prize winner, one (1) Second Place and one (1) Third Place winner.
 - a. The Grand Prize winner will receive a prize that will include a \$400 Food City Gift Card along a Target Gift Card (value of \$600).
 - b. Second Place will receive one (1) \$300 Food City Gift Card and a \$100 Target Gift Card (value of \$400)
 - c. Third Place will receive one (1) \$200 Food City Gift Card.
2. Grand Prize winner prize will be coordinated for an in-person pick-up at the Bashas' Support Center in Chandler, Arizona. Remaining prizes will be mailed certified letter to the winner's home, with a signature required for proof of identity.
3. There is no substitution, transfer, or cash equivalent for prizes, except that Food City may, at its' sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses.

2. How to Enter:

1. Sweepstakes will begin on July 10, 2023 at 12:00 a.m. Mountain Standard Time ("MST") and end on August 14, 2023 at 11:59 p.m.
2. To be eligible, entries must be received within the sweepstakes timeframe and will be based in MST and timestamp of the submission email.
3. To enter online, you must enter your name, address, zip code and valid email address or phone number. Limit one internet entry per household and one internet entry per email address per contest period. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning email address or the domain associated with the submitted email address. Food City ("Sponsor") is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches. For entry into the sweepstakes without completing the online entry, mail a 3" x 5" card containing all entrance submission information in an envelope no larger than 4 1/8" x 9 1/2" "to: Food City Hatch Chile Contest, PO Box 488, Chandler, AZ 85248. Mail-in entries must be postmarked August 14. Sponsor assumes no responsibility for incomplete, damaged, misdirected, illegible, late, stolen or lost entries. One mail-in entry per household.

3. Eligibility Restrictions:
 1. The sweepstakes is open to adults who are 18 years of age or older and legally reside in Arizona or New Mexico. Employees of Food City, affiliated entities, their affiliated advertising agencies, participating sponsors/promotional partners and the members of their immediate families are ineligible to participate or win.
4. Selection of Winners:
 1. Following completion of the entry period, all submission will be reviewed by the Food City Public Relations Department. Finalists will be identified and announced on August 21st.
 2. All judges will score each donut on a 1 to 10 scale with 10 being the highest single judge points awarded. Points are tallied from all judges for all hatch chile recipe submissions to determine the winners.
 3. Three (3) winners will be notified via e-mail or phone on August 21st.
5. Conditions:
 1. Payments of all federal, state and local taxes are the sole responsibility of the winner. Winner may be required to sign an IRS Form W-9 or the equivalent.
 2. By participating in the contest, the winner agrees to have his or her name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and to sign a publicity release confirming such consent prior to acceptance of the prize.
 3. Sponsor in their sole discretion reserve the right to disqualify any person tampering with the entry process, the operation of the Sponsor's Websites or is otherwise in violation of the rules. Sponsor further reserves the right to cancel, terminate or modify the contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
